




RECIPROCAL AGREEMENT

The Reciprocal Agreement between Neeti Bagh Club, New Delhi and the Engineers Club, Kochi, mutually agree to extend the use of facilities and privileges to the visiting members as per terms and conditions of the Host Club, as follows :

1. This arrangement will be available only to the bonafide permanent members (or any such category of membership). Temporary members (or any such category of membership) shall not be eligible for this arrangement.
2. Dependents of Reciprocal Club members (spouse and children upto the age of 21 years) are allowed to use the facilities alongwith the visiting member.
3. The visiting member must present his/her updated Membership Card issued by his/her Home Club or an introductory letter duly signed by the authorized signatory from the Home Club, for entitlement to use the Club facilities as per Rules of the Club.
4. Reciprocal members are not allowed to be accompanied by guests.
5. The visiting members entitlement shall be restricted to a maximum of 48 days in a calendar year/4 days in a month.
6. Reciprocal members will not be allowed to use the facilities of the Affiliated Club if he/she is or becomes a permanent resident in the city/town of the Affiliated Club.
7. Reciprocal members can avail of the residential facilities subject to availability and shall adhere to the relevant Rules of the Club.
8. All Bills/Payments of the visiting members has to be settled directly by him/her in cash/credit card where accepted, before leaving the premises. Taxes shall be additional wherever applicable.
9. This Agreement will be effective immediately and shall remain in effect until terminated by either of the Club by giving 30 days prior notice.
10. All norms mentioned in the Fact sheet of Neeti Bagh Club shall be applicable.

The above terms and conditions may be amended from time to time by mutual consent
