RECIPROCAL AGREEMENT

Affiliation and Reciprocal Arrangement for availing club facilities for visiting members of

Umed Club, Jodhpur a club registered under the Societies Registration Act having its registered address at Old Public Park, Near Gaushala Grounds, Jodhpur.

AND

Neeti Bagh Club, a club having its registered address at Supreme Court Bar Co-Operative House, Building Society Limited, Neeti Bagh, New Delhi 110 049

On following terms & conditions formulated/amended from time to time in mutual consultations with each other:-

- 1. This agreement is only for providing a reciprocal arrangement to the members of the respective clubs for availing the facilities made available from time to time by the management of the host club. Each of the clubs shall in no way be responsible for the acts of its reciprocal affiliate other than for the purpose of providing reciprocal arrangements for its valued members.
- 2. The visiting member shall carry a valid club identity card of the parent club to avail facilities at the host club.
- 3. The visiting members shall be allowed four visits to the host club in a calendar month subject to maximum 30 visits in a calendar year.
- 4. The visiting member shall not be entitled to introduce guest, accompanying the visiting member at the host club.
- 5. The members hereinafter referred to as visiting members shall include spouse and dependent children holding valid club identity card of the parent club.
- 6. The visiting member will be required to produce their club identity card, sign visitor's book, specify business and other things/ details, date of visit, intended stay.
- 7. The visiting member/s and their guest/s shall be bound by the extant Rules & Regulations and Bye Laws of the host club as applicable from time to time. Any breach of the same shall debar the visiting member and their guest/s from using the facilities of the host club and shall be liable for appropriate disciplinary action at the parent club.
- 8. Residential facilities should be enquired and confirmed in advance as per the norms of the host club.
- 9. The visiting member/s shall be solely/jointly responsible for all acts and dues of their guest/s.
- 10. All the bills of the visiting member/s, guest/s have to be settled in cash/ credit card before leaving the host club by the visiting member, as per the system adopted by the host club. No credit shall be extended.

14. Affiliated Club Members have to produce the Introduction Letter, duly signed issued by the affiliated club with validity date and Residential Address registered with the Club for visiting and availing the facilities of the Club, in addition to the individual Identity Cards issued by the concerned Clubs for Members and their family members.

15. Only Members of the Affiliated Club residing outside Jodhpur and Jodhpur District will be entitled to avail the facility of the Club.

16. Affiliated Club Member shall pay Entrance fees as decided by the host club from time to time.

17. Entry will be banned for Affiliated Club Member/s and their Guest/s on every Saturday and Sunday.


